Terms of reference for a senior international consultant to support the production of the CESA/SDG 4 baseline Continental Report

PRESENTATION OF IIPE-UNESCO DAKAR

L'IIPE-UNESCO Dakar, situé à Dakar, au Sénégal, est le bureau pour l'Afrique de l'Institut international de planification de l'éducation de l'UNESCO (IIPE-UNESCO). L'IIPE est un institut spécialisé de l'UNESCO, dont le mandat est de renforcer la capacité des États membres de à planifier et à gérer leurs systèmes éducatifs. L'IIPE-UNESCO Dakar est réputé pour ses analyses du secteur éducatif et aide les pays africains à élaborer des plans crédibles de développement des systèmes éducatifs dans le cadre de l'agenda 2030 pour l'éducation.

Par une approche de renforcement des capacités, l'IIPE-UNESCO Dakar contribue à la production d'analyses diagnostiques, de plans sectoriels et d'outils pédagogiques qui contribuent à des politiques éducatives plus pertinentes et durables. L'IIPE-UNESCO Dakar est également activement impliqué dans la production de connaissances pour le secteur de l'éducation en Afrique. CONTEXT AND RATIONALE

At the Pan African Conference on Education (PACE 2018), members States instructed the African Union and the United Nations Educational, Scientific, and Cultural Organization (UNESCO) to work together to produce, on a regular basis, the continental monitoring report for both the Continental Education Strategy for Africa (CESA) and Sustainable Development Goal (SDG) 4.

Within the fast-approaching deadline of 31 December 2030 for countries to meet their SDG commitments, it is imperative that a Continental report be issued in 2021 as the first continental baseline to take stock of the five years of implementation of the two agendas since 2015 for SDG4 and 2016 for CESA. IIEP-UNESCO Dakar will lead the technical development of the report, in close collaboration with UIS¹ and UNESCO regional and country offices, as well as with the GEM Report² team.

The quantified and time bound targets of the CESA strategic objectives that were adopted in 2015, led by Heads of State, represent an epic effort in Africa to contextualize the global SDG agreement. Annex 2 sets the linkages between the CESA strategic objectives and the SDG targets. The targets mentioned in the Annex are associated with various measurable indicators for monitoring progress at both country and continental level.

The goals and objectives of the Continental Report are as follows:

- 1. To reexamine Africa's achievements in implementing both CESA and SDG 4 in details and in a consolidated framework.
- 2. To develop a scorecard for the continent, which will be used to monitor progress and achievement of its targets and commitments, with baseline data that will contribute to assess progress from the perspective of 2 agendas.

- 3. To record the lessons learnt including the foundations for successful achievements: this includes reviewing current innovative practices, prioritizing policy and institutional reforms, identifying means of policy implementation, and evaluating financing options.
- 4. To highlight the magnitude of the data crisis in African countries, which hamper a continental development of quality education for all based on sound evidence. The report will help to identify data gaps, lessons from national monitoring systems that work well, investment needs in data production and associated capacity development in the continent.

The Continental Report 2021 targets a broad audience including policymakers, the general public, international and bilateral institutions and partners, academia, the education experts' network and media. A database of all calculated and gathered indicators serving as baseline for the monitoring the two agendas will also be produced.

Data for the continental joint reports will be mainly provided by the UIS, with its global mandate to collect data for monitoring the SDG4. From an initial assessment, about 50% of CESA indicators are already covered in UIS global annual surveys in formal education. In addition to data collected through the African Union institutions, UNICEF and UNHCR, complementary sources of data will be explored subject to their alignment to international statistical norms and standards to ensure comparability across countries and overtime.

In addition, UNESCO and African Union Commission (AUC) will mobilize their networks at the country level to facilitate the collection of qualitative data to document the domestication of the two agendas as reflected in the national policies and legislations, plans and strategies. Different national report such as Education Sector Analysis and other relevant reports/studies such as sectoral revue meeting reports, policy analysis reports, will be used to have additional data and evidence related to the CESA and SDG4.

The production of the Report will be done under the guidance of two committees, and following the schedule outlined in Annex 1:

- A Steering Committee will examine and validate the inception report (including the outline), review the draft final report and the final report, and to guide the Editorial Committee and the IIEP Dakar in both policy and substantive matters.
- An Editorial Committee will review and provide comments on the various drafts of the report before submission to the Steering Committee.

To assist with the production of this major publication, IIEP Dakar is recruiting two mid-level consultants to support, respectively, the quantitative and qualitative analysis that will feed into the Report, and one senior consultant who will oversee the work and be responsible for the writing of the report.

These Terms of Reference describe the duties and qualifications of the senior consultant.

DESCRIPTION OF WORK AND DUTIES

Under the direct supervision of IIEP Dakar's Research and Development Programme Manager and the overall supervision of IIEP Dakar's Head and Deputy Head of Office, and with the support of the qualitative and quantitative analysis consultants, the senior international consultant will be responsible for the overall production of the Continental Report.

Specifically, the consultant will, with guidance and support from the R&D Program Manager, and in close collaboration with the UNESCO Dakar regional office:

- 1. Propose, discuss with IIEP Dakar and present to the Steering Committee, jointly with the IIEP Dakar, an outline for the Continental Report;
- 2. Guide the qualitative and quantitative analysis consultants in their respective activities (data collection and analysis, research and productions, etc.) to ensure the content of the Report is adequately documented, the indicators are accurately analysed and narrative highlights relevant trends, making the necessary links with policy and institutional reforms options;
- 3. Identify key issues related to the achievement of the CESA and SDG4 targets for discussion in the Report;
- 4. Support, and where necessary participate in, the consultation of international and national partners for the identification and description of the innovative practices, prioritizing policy and institutional reforms, identifying means of policy implementation, and evaluating financing options;
- 5. Identify key tables and visuals (including charts and maps) to illustrate the analysis in the report;
- 6. Collate the inputs of the qualitative and quantitative analysis consultants into the agreed upon outline of the report, ensuring internal coherence balance between the various sections and chapters;
- 7. Co-lead, with the R&D Program Manager, the design of the scorecard for monitoring CESA and SDG4 indicators, at continental and country level;
- 8. Draft the Introduction, and support the graphic design of the Report;
- 9. Propose and draft, in collaboration with the R&D Program Manager, key policy recommendations stemming from the diagnostic and the data gaps presented in the Report;
- 10. Prepare and present to the Editorial Committee, jointly with the IIEP Dakar, the draft and final versions of the Continental Report;
- 11. Co-lead, with the R&D Program Manager, the collaboration with the UNESCO GEM Report team on the Spotlight report for Africa, ensuring an optimal articulation and cross-fertilization of both reports.

DURATION AND DELIVERABLES

The consultant will be recruited for a period of six months from April to September 2021. They are expected to work remotely and deliver the following outputs.

- **Deliverable 1**: An inception report, including an outline for the Continental report, discussed and agreed upon with IIEP Dakar, for submission to the Editorial and Steering Committees;
- **Deliverable 2**: An interim report, presenting a detailed outline of the Report, with the key tables and charts to be included, and the country innovative practices to be featured;
- **Deliverable 3**: A template for the scorecard;
- Deliverable 4: A first draft of the Continental Report for review by the Editorial Committee;
- Deliverable 5: A second draft of the Continental report, taking account of the feedback from the
 Editorial and Steering Committees, and including the introduction, the recommendations and the
 full set of scorecards, at continental cand country level;
- **Deliverable 6**: The final version of the Continental Report.

REQUIRED QUALIFICATIONS

- Advanced university degree (Master or equivalent) in education, economics, social sciences or related fields.
- At least ten years of work experience in research, monitoring and report writing in education, including at least five at the international level.
- Strong analytical and writing skills.
- Proven experience in leading teams to produce high quality outputs.
- Experience in coordinating teams working remotely from different countries and continents a strong advantage.
- Very good knowledge of educational issues in Africa.
- Prior experience in similar responsibilities is highly desirable.
- Excellent proficiency (written and oral) in English. Good knowledge of French is an advantage.

Interested candidates must submit their application **before 4 April (midnight Dakar time)** with the following required information:

- An up-to-date CV stating details of educational qualifications, work experience, including prior experience of similar work.
- A technical and financial offer, outlining the understanding of the assignment, highlighting the relevant experience, and presenting a proposed remuneration for the work (professional fees only no other costs will be eligible)
- If available, examples of similar work and publications.

- Only applications providing the information requested will be considered.
- Evaluation of qualified applicants may include an interview.
